

Privacy Policy for Ofiat.com Extension

Effective Date: May 5, 2025

This Privacy Policy ("Policy") outlines the manner in which Ofiat.com ("we," "us," or "our") collects, uses, discloses, and safeguards information through our browser extension (the "Extension") designed to facilitate e-commerce checkout by generating and applying digital gift cards and vouchers.

1. Information We Collect

We collect and process the following categories of personal and non-personal information:

- ****Email Address****: Collected solely for authentication and login purposes.
- ****Cart Total Amount****: Accessed via the Document Object Model (DOM) of supported e-commerce sites solely to determine the accurate payment amount required for applying the correct gift card or voucher.

We do not collect any additional personally identifiable information unless voluntarily provided by the user for customer support or feedback purposes.

2. Information We Do Not Collect

We expressly do not collect, store, or process the following data:

- Passwords or authentication credentials for third-party platforms;
- Credit or debit card information;
- Comprehensive browsing history beyond supported e-commerce sites;
- Any data that directly identifies an individual beyond the email address provided for login.

3. Purpose of Data Collection

The aforementioned data is collected and used strictly for:

- Enabling core functionality of the Extension;
- Ensuring accuracy in payment amount processing;
- Improving the reliability and compatibility of the Extension;
- Preventing fraudulent use and abuse of services.

We do not sell, lease, or share personal data with third-party advertisers or marketers.

4. Data Storage and Security

All critical operations are performed locally within the user's browser. Any data transmitted to our servers is limited to anonymized, non-personal operational metrics. Such data is:

- Encrypted during transmission using industry-standard protocols;
- Retained only for diagnostic and performance-related purposes;
- Protected against unauthorized access using appropriate security measures.

5. Use of Third-Party Services

Our Extension may interface with third-party service providers for the issuance and redemption of digital gift cards and vouchers. These providers are vetted for their compliance with relevant data protection regulations and receive only the data necessary for fulfillment operations.

6. Cookies and Tracking Technologies

The Extension does not utilize cookies, web beacons, or any form of tracking technology for behavioral profiling or targeted advertising.

7. User Rights

Subject to applicable data protection laws, you may have the right to:

- Access personal data we may hold about you;
- Request deletion of data provided for support purposes;
- Opt out of anonymized diagnostics collection through your browser settings or support request.

8. Children's Privacy

The Extension is not directed to individuals under the age of 13, and we do not knowingly collect personal data from children. If we become aware that we have inadvertently collected such data, we will take steps to delete it promptly.
